SAFETY RULES

1. I will sign a Camp X APPLICATION TO PLAY form prior to the day or session of activity, and acknowledge that this agreement is binding.
2. I will follow all special instructions (including these rules) which the game operator or their agents may give prior to each game.
3. I will read and obey all signs posted regarding goggles and barrel plugs/sleeves.
4. I will adjust the velocity of my paintball gun to shoot below the posted maximum for each game I play.
5. Every time I play I will wear approved goggles and other required safety equipment at all times within the playing, chronograph, and target areas.
6. I understand that I will be ejected from the game for unauthorized removal of my goggles within the playing, chronograph, and target areas.
7. I will keep my paintball gun barrel plugged or covered at all times while outside of the playing, chronograph, and target areas.
8. I will use only paintball equipment approved by the CPL and the field operator or sponsor.
9. 911 is the local emergency telephone number.
10. I will not use illegal drugs or alcohol of any type before or during paintball game activities.
11. I will abide by all decisions of the referees and playing field officials.
12. I will stay within the playing field boundaries at all times while I am playing the game.
13. I will NOT climb trees or participate in any other unsafe activities while playing paintball.
14. Should I see or believe that another player might be injured, I will immediately stop the game and assist that player.
15. I will assist the field operator or sponsor in keeping the playing field boundaries well marked.
16. I am playing this game for fun and will refrain from foul language, and will not engage in any arguments or physical contact of any kind.
17. I will make myself familiar with the local emergency telephone numbers and with any safety or first aid equipment available in the event of an accident.
18. I agree to abide by all applicable federal, provincial, and local laws governing the playing of this sport.

RELEASE OF LIABILITY

IN CONSIDERATION of being permitted to participate in any way in the sport and activities of paintball under the auspices of CAMP X, I acknowledge, appreciate and agree that:

1. The risk of injury from the activity and weaponry involved in paintball is significant, including the potential for permanent disability and death, and while particular protective equipment and personal discipline will minimize the risk, the risk of serious injury does exist.
2. I ACKNOWLEDGE AND FREELY ASSUME SUCH RISKS, both known and unknown EVEN IF ARISING FROM THE NEGLIGENCE of those persons released from liability below, and assume full responsibility for my participation; and,
3. I understand that the activities of paintball are physically and mentally intense. I understand the rules of play and will comply with all rules and regulations. If I observe any unusual or unnecessary hazard during my participation, I will bring such to the attention of the nearest official as soon as practical; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin, HEREBY RELEASE AND HOLD HARMLESS CAMP X, the owners and lessors of premises used to conduct the paintball activities, their officers, officials, agents and/or employees ("Releases"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH or loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, except that which is the result of gross negligence and/or wanton misconduct.
5. I understand and agree that this Release of Liability Agreement covers each and every paintball activity and event in which I participate hereafter.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND IT'S TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
